

# SAIN in 2019 - the Key Milestones, Events and Partners

2019 has been a busy and successful year for the UK China Sustainable Agriculture Innovation Network (SAIN).

Through working with partners in the UK and China, SAIN has achieved a number of important milestones to strengthen the cooperation between the two countries:

- Co-organised the UK-China Agriculture Green Development Workshops with Rural Energy and Environment Agency (REEA) of the Ministry of Agriculture and Rural Affairs (MARA) in Beijing and Yunnan;
- Initiated the "Pledge for Promoting UK China Cooperation in Agricultural Green Development" which was signed by Chinese and British governmental officials, scientists and advisers;
- Delivered15 seminars and workshops covering a wide range of topics of soil health, arable land quality monitoring and assessment, agricultural waste recycling, digitalization in agriculture and rural development, climate smart agriculture, and policies and legislation in rural vitalization;
- Built new cooperative partnerships with governmental organisations, academic institutes, NGOs, business and farm organisations in the two countries;
- SAIN was named in the 10<sup>th</sup> UK China Economic and Financial Dialogue (EFD)
   Policy Outcomes as a mechanism to support the agricultural cooperation between the
   two countries. This was the second time SAIN was named in the EFD Policy
   Outcomes.

The following events reflect some of the milestones achieved in the year.

#### **25 March 2019**

Workshop on Agriculture Green Development, co-organised with Rural Energy and Environment Agency (REEA) of the Ministry of Agriculture and Rural Affairs (MARA), held in Beijing, attended by over 70 participants from MARA and academic organisations.



### **27 March 2019**

Workshop on Rural Clean Energy and Green Development, co-organised with REEA, Yunnan Provincial Department of Agriculture and Rural Affairs, held in Dali, Yunnan Province, attended by over 200 participants from all over China.



#### **29 March 2019**

Forum on the pathways for agriculture green development, co-organised with National Academy of Agriculture Green Development, held in China Agricultural University (CAU), Beijing.



#### **27 May 2019**

UK China Agriculture Green Development Forum, held in UK Pavilion at International Horticultural Expo, Beijing. The participants of the Forum signed the "Pledge to Promote UK China Cooperation in Agriculture Green Development".





#### **17 June 2019**

SAIN was highlighted in the Policy Outcomes of the 10th UK-China Economic and Financial Dialogue, as a mechanism to support the cooperation in agriculture between the two countries<sup>1</sup>.
